I am writing this letter to show our support for the prioritization of funding the Oakes Irrigation Research Site by SBARE in the 2023-2025 biennium.

As the Executive Director of the organization contracted to do economic development in the city of Oakes, I believe this research site to be a highly underappreciated, underutilized, and potentially, even misunderstood asset to the region.

At the 2017 biennium, my father, Tom Rodine, a 4th generation farmer, testified to your committee in Bismarck, resulting in the operational funding of this site being placed as the 2nd highest priority for SBARE in the 2017-2019 biennium.

At that time, the Oakes Irrigation Site had been funded through the Garrison Conservancy District and it was clear that this funding would no longer be available in the future. That future has now arrived and without your funding, Garrison Conservancy District will fully divest from this project, forcing the only state-funded research site in southeast North Dakota to close, abandoning decades of successful research.

The research conducted on the site is accessed by multi-global companies to support the development and innovation of dozens of agricultural inputs. This research facility, if allowed to not only remain open but also improved to keep pace with other facilities of its type, positions Oakes and the southeast region of North Dakota as an agricultural hub for innovation and advancement.
